Trouble-Free Rental

We hope that you enjoy the freedom experienced by hiring a car to 'See South Africa'. In order to ensure that you enjoy your experience and have a trouble-free rental, Gateway has put together some pointers for you.

Pick-Up & Drop-Off

Pick-up and Drop-off times are extremely important. Daily rates are calculated strictly in cycles of 24 hours (twenty-four) from the time of pick up to the time of drop off. For example, when a vehicle is collected at 08h00 on day one and returned the next day at 08h00 this constitutes as a one (1) day rental and no grace period will be allowed at return of vehicle. Should the vehicle be returned at 08h30, an extra day charge will be billed directly on your credit card. Remember to always give yourself enough time to ensure that you drop the car off in time.

Rental Conditions & Additional Charges

Upon collection of the rental car, the driver /renter must be in possession of a valid unendorsed driver's license (in country of residence) and a valid credit card. The credit card must be in the name of the renter. Only credit cards / Hybrid cheque cards are accepted. The card must display a Mastercard or Visa logo, the numbers must be raised on the card as on a credit card with the words "Cheque Card" reflected on the back or front of the card. No cash or debit cards are accepted. There is a difference between the deposit amount between the cheque card and credit card process.

- Visa, MasterCard and American Express credit cards are accepted.
 African Bank credit/debit/cheque cards are not accepted.
- International debit cards are not accepted as a form of payment.
- An additional fee will be charged for a young driver under the age of 23, provided that they are in possession of a valid, unendorsed driver's licence for a minimum of (3) three years.
- Irrespective of what is stated elsewhere in the Rental Agreement, the Vehicle may not be driven during the rental period or any extension thereof by any person who has not been in possession of a valid unendorsed driver's licence (in respect of the specific vehicle/code of vehicle rented) for at least 3 years.
- Should the renter choose to extend his/her rental beyond the original return date Europcar must be informed. Failure to inform Europcar may result in the vehicle being reported as stolen and all waiver cover is negated. Should the rental vehicle not be returned by the agreed date and no prior arrangements have been made to extend the rental, the vehicle will be collected by Europcar and an overdue rental administration fee will be levied.
- Should the renter, extend his/her rental, and extension documentation is not produced from the operator, Europear will bill the renter for additional days at the extension rates.
- Should the rental exceed 30 days, then an additional rental agreement will apply for each period of 30 days. Additional documentation to cover the additional periods is required.
- The Client warrants that the vehicle will never be driven by any person whose blood alcohol concentration exceeds the limit permitted by any law or regulation or whilst under the influence of intoxicating liquor or of a narcotic drug or similar substance. The client further warrants that every driver of the vehicle will have a valid unendorsed driver's license for at least 3 years to drive the specific vehicle code/type and will comply with all applicable laws and will comply with all of the provisions of the rental agreement.
- If the vehicle is driven by anyone other than the driver and / or additional driver (irrespective of which other rights or remedies Europear may have), the client shall remain liable for all of his liabilities and obligations in terms of the rental agreement as if he has been driving the vehicle. In the even the vehicle is driven by anyone other than the driver and /or additional driver at any time during the rental period, any waiver option the client may have taken out shall become null and void.
- The client also warrants that he is entitled and authorised to enter into the rental agreement and that all particulars given to Europear and/or recorded on the rental agreement are true and correct.
- Auto billing/ authorisation will be obtained on your credit card/cheque/debit card for the following additional charges over and above the rental deposit
 and excess liability hold:

- A one way drop off fee will apply when a vehicle is not returned to the same branch that it was collected from. This fee is payable directly to Europear. One-way fees are available on request.
 - Credit Card authorisation will be taken at the time of rental in accordance with the below schedule:
 - Refundable rental deposit of approximately R1 860 to cover any additional items not included. (Amount varies according to vehicle group and rental duration
 - R360 toll fee deposit
 - Standard Waiver Product (E1) the authorisation is equal to 40% of the excess liability plus a rental deposit of ZAR1 860.
 - Super Waiver Product (E2) the authorisation is equal to 40% of the excess liability plus a rental deposit of ZAR1 860.

- In the event of NEGLIGENCE, all waivers are negated. The renter will be fully liable for all damage and associated costs.
- Liability is not limited to the value of the authorisation taken

Collision Damage/Theft Waivers - Refer Terms and Conditions of Rental

The Gateway contracted rates are based on two waiver options: Standard Waiver and Super Waiver for Collision Damage Waiver (CDW) and Theft Loss Waiver (TLW). Such cover is subject to the terms and conditions of Europear.

Standard Waiver and Super Waivers are available for the reduction of liability in the event of loss, theft and/or damage to the vehicle excluding tyre and windscreen damage. Liability amounts are applicable to CDW and TLW. The renter will be financially responsible in the event of theft or damage to the Europear vehicle, according to the terms and conditions of rental. The renter is therefore responsible, in the event of theft or damage to the Europear vehicle as per the below schedule. Items of a personal nature are not covered under CDW or TLW.
